

Name of the Trust:

Office of the Trust:
 Office of the trust will be at : 54,5wagat Duplex, Tandelja Road, Muktinagar, Baroda-20, and if needed in future, changes will be made, and the branches shall be open.

Area of Operation:

The area of operation will be at present be the Vadodara district and can be extended to all over India, subject to the provision to the Act.

Objects of Trust:

The Trust will never discriminate any person with respect to religion, caste, creed, state, language, while working for trust object. The object of the trust are defined as under:

Educational: To make development in the find of education by establishing, maintaining and running Baby sitting House, Day care center (Balwadi), Primary School, Secondary School, Higher Secondary School, Technical School, Health Educational School, and School and to help in similar activities. and also to administrate the other institutions having common activities.

To provide training for educational knowledge of Mind, Health, Industry, commerce, science, agriculture, technical and doctor. Also provide adult education facility.

- 2. Health: To provide all facilities for maintaining health of Health: To provide all facilities for maintaining health of general public. To provide help in the activities of mily planning and to organize camp. To provide facilities of pharmacy, blood bank, ambulance, and also provide other facilities by establishing, maintaining, developing and running hospital, medical care center, dispensaries, clinics, research center, laboratory of Ayurvedic, Homeopathic, Allopathic, and Unani medicine. To established and maintained nature cure center and to help in this type of treatment. To undertake health research activities.
- 3. To undertake charitable activities of religious and cultural welfare for general public.
- Social service: To help affected people due to natural and man-made calamity such as flood, famine, earthquake, epidemic disease ect.

- Good Education: For the purpose of good education, to undertake all activities-for propaganda and spread of non-religious so that will be build similar to historical culture of
- Scholarship: To administer, run and maintain loan, scholarship, facility of hostel and library for the purpose of help and encouragement to needy students.
- Competitions: To undertake welfare activities and to organize seminar, expert conference, debate competitions, writing / drawing / other competitions and to encourage for the development of society.

#### 9. Bye-laws:

For the purpose of objects of the trust, Trust shall make byelaws by resolution according to the provisions of this trust deed and provisions of the Bembay Public Trust Act, 1950.

### 10. Sub-Committee:

Board of trustee may make sub-committee for special task for the objects of the trust.

# 11. Trustees Meeting and their work:

Three days advance notice for meeting will be given and activity shall be done accordingly. The postponed meeting, due to lack of quorum, shall be meet after half hour at the same place. and nobody will be inform again. The minimum quorum will require 1/3 member. But If there are only three trustees in the trust, in this circumstances the minimum quorum will require presence of 2 trustees.

The board meeting will approve the annual report and income and expenditure account and the Balance sheet, and will appoint auditor, and shall make necessary rules and regulations of shall approve necessary changes or shall cancel the rules.

## 12. Properties of the Trust:

The existing movable and immovable properties of the trust and the new properties which are purchased or collected by the trust shall be the properties of the trust.

### 13. Sources of Income:

Trust will generate the income by donation, gift, interest, government and semi-government grant, help and the income from cultural programs.

# 14. Vesting of properties of the Trust:

All the movable and immovable properties of the trust shall be vested to managing committee in the name of the trust. Managing committee shall administrate and arrange all that properties according to this document.

15. Power to appoint employees:

The employees shall be appointed by majority resolution for specific task by the Board of trustees and these employees shall

be paid by salary and in the interest of the Trust, they can be relived by resolution, and also decided appointment conditions.

16. For changes in this trust deed:

If the additions or alterations are to be incorporated in the trust deed, it shall be done by written resolution by majority.

17. Winding up:

This trust can be dissolved by the trustees of the board of trustees in its special meeting specifically convened for the purpose, by absolute majority of the trustees.

The assets and properties shall be denoted to other trust with similar objectives.
